Epigenetic feedback, non-coding RNA (ncRNA) regulation, and quantum coherence facilitate these oscillations across molecular systems, dynamically responding to environmental inputs and quantum states.

Mathematical Proofs

Proof 1: Oscillatory Model of Genetic Information Transfer

We begin by mathematically modeling transcription and translation as oscillatory functions driven by sine-cosine duality, central to ODTBT.

Step 1: Sine-Cosine Duality in Transcription and Translation

Gene expression can be modeled as oscillatory functions, where transcription (DNA → RNA) and translation (RNA → protein) follow periodic cycles of potential (continuous) and realization (discrete).

The oscillatory dynamics of gene expression can be described by the function:

Protein folding involves the simultaneous exploration of multiple conformational states (quantum superposition). The transition from these states to a single functional conformation is modeled as an oscillatory collapse.

We define the quantum coherence of protein folding as:

$$\psi_{\text{folding}}(t) = \sum_n c_n (A_n \sin(\omega_n t) + B_n \cos(\omega_n t))$$

where:

- c_n is the probability amplitude for each conformational state,
